To be considered for certification as a Drug Recognition Expert, you must successfully complete all three phases of training:

1. Drug Recognition Expert (DRE) School—72 Hours

This course will train law enforcement officers in the areas of physiology, vital signs, SFSTs, and the seven categories of drugs of abuse. This training includes two written exams, an SFST proficiency exam, and five written quizzes. Students are required to score a minimum of 80% on the two written exams and must demonstrate proficiency in administering SFSTs in order to be considered for the final stage of training.

2. Field Certification

Upon successful completion of the academic portions, each student must then complete the certification phase. This requires the student to conduct a minimum of 12 drug influence evaluations while under the supervision of a DRE instructor. The student must identify subjects under the influence of at least four of the seven drug categories and attain a toxicological confirmation rate of at least 75%. In addition, the student must maintain a progress log, rolling log, and create a curriculum vitae.

3. Final Knowledge Exam and Endorsement

The student must score a minimum of 80% on the final knowledge exam and obtain the written endorsement of two certified DRE instructors and the state coordinator. Unless otherwise noted, the certification phase will take place out-of-state.

1. Successful completion of the Advanced Roadside Impaired Driving Enforcement (ARIDE) class. Note: Completing ARIDE Online will not be accepted.
2. Have at least two years of service as a certified law enforcement officer.
3. Be certified and proficient in administering Standardized Field Sobriety Tests.
4. Have a reasonable background and experience level in investigating DUI cases.
5. Submit a letter of recommendation from a local prosecutor. May also submit additional letters of recommendation from other sources.
6. Submit at least two of your DUI arrest reports for review.
