Application Instructions and Acceptance Criteria

1. Applications must be received within sixty (60) days of desired school date.
2. Handwritten applications will not be accepted. This application must be completed in electronic form except where a signature is required.
3. Advanced Roadside Impaired Driving Enforcement (ARIDE) is a mandatory prerequisite to the DRE School. You must have successfully completed the classroom version of the ARIDE course within the past 5 years. The online ARIDE course offered by NHTSA will not satisfy this requirement. Please provide the location of the course and dates of attendance in the boxes on the application.
4. Submit a letter of recommendation from a local prosecutor. May also submit additional letters of recommendation from other sources.
5. Submit at least two of your DUI arrest reports for review.
6. Candidates will be notified of their application status via email.
7. Applicants must be off of probation with their agency and must have at least two years of service as a certified law enforcement officer and be certified and proficient in administering Standardized Field Sobriety Tests.
8. Applicants must have reasonable background and experience level in investigating DUI cases.
9. All applications must have the required supervisory signatures.
10. Applications may be emailed or mailed via the United States Postal Service.
11. **Applicants found to have falsified information on this application before or after the course has started, will not be considered for enrollment or will be dismissed from the course.**
12. **Applicants must give permission for criminal and driving history check.**
13. **Incomplete applications will not be considered.**

DRE Training is extremely demanding. To receive certification as a DRE, three phases of training must be completed: **Phase 1 and 2 (Academic/Classroom segment)** is held at a regional training location.

Phase One- DRE Pre-School is conducted over two days. The training includes the SFST proficiency test and one quiz where the student must achieve a minimum of 80% in order to continue to Phase two.

Phase Two- DRE Main School is conducted over seven days and will include courses in physiology, vital signs, standardized field sobriety testing (SFST), as well as extensive material on each of the seven drug categories of abuse. There will be four written quizzes and a Phase 2 Final Examination consisting of 100 questions. Students must achieve a minimum of 80% on the examinations and must demonstrate expert proficiency in administering SFST in order to progress to Phase Three.

Phase 3 DRE Field Certification: Upon successful completion of Phases 1 and 2, students will travel to the designated field certification site. Under the close supervision of DRE Instructors and the State Coordinator, students will complete evaluations on several drug impaired subjects. Each student is required to conduct a minimum of 12 drug influence evaluations. Each student must successfully be able to identify subjects under the influence of three of the seven drug categories. In addition, the student will maintain a progress log and a rolling log of these evaluations. The student will prepare and submit a curriculum vitae. At the conclusion of Field Certifications, students will participate in the Final Comprehensive Knowledge Examination and must receive a "pass" grade from 2 DRE Instructors and the State Coordinator. The Alabama Impaired Driving Enforcement Program is credentialed by The International Association of Chiefs of Police (IACP) and strictly adheres to the standards as set forth by IACP. DRE Certification is valid for two years and DRE's are required to conduct a minimum of four evaluations, submit a rolling log, and a current curriculum vitae every two years. Additionally Alabama State DRE's must attend eight hours of approved re-certification or in-service training every 2 years and conduct one evaluation with a DRE Instructor annually to maintain Certification.

Applicant Signature - By signing below, it is understood by the applicant that he/she has given permission to the DRE State Coordinator and Oversight Committee to review their driving and criminal history. It is further understood that any information on this application found to be false will result in expulsion from the program. The DRE Program is an advanced DUI enforcement program and therefore requires applicants to have above average character and strict compliance of impaired driving laws.
